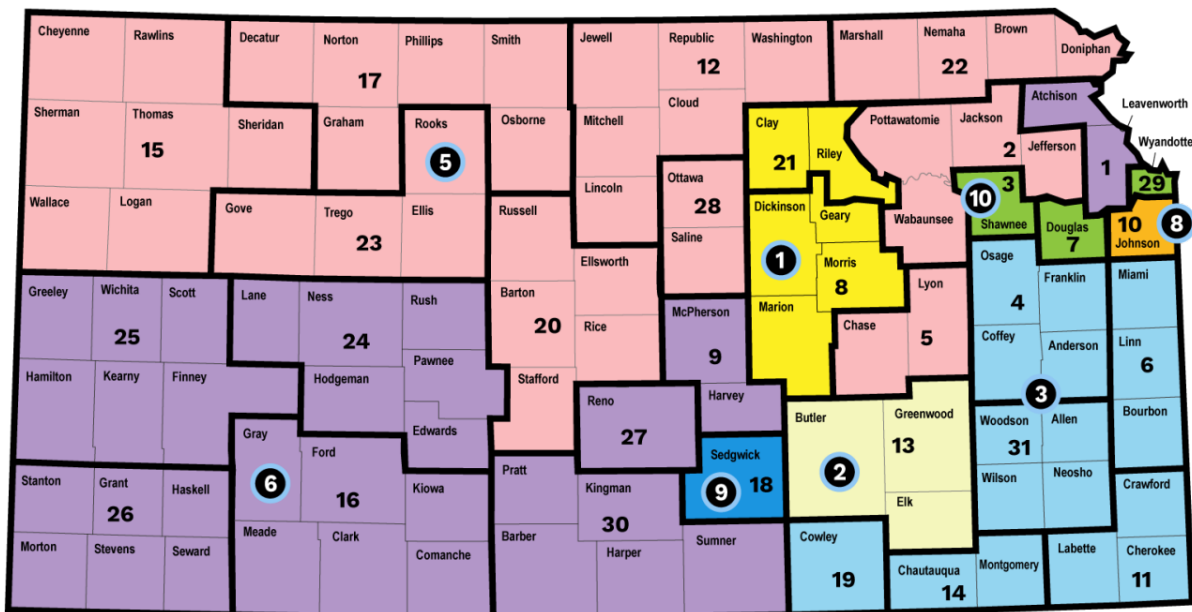




Kansas eCourt: CCMS Project Update (8-26-22)



Track 6 courts go-live date is September 12

District courts in Track 6 are scheduled to start using the Kansas eCourt case management system September 12. Track 6 includes 34 counties and eight judicial districts.

Courts in Track 6 are:

- 1st Judicial District: Atchison and Leavenworth counties
- 9th Judicial District: McPherson and Harvey counties
- 16th Judicial District: Clark, Comanche, Ford, Gray, Kiowa, and Meade counties
- 24th Judicial District: Edwards, Hodgeman, Lane, Ness, Pawnee, and Rush counties
- 25th Judicial District: Finney, Greeley, Hamilton, Kearny, Scott, and Wichita

counties

- 26th Judicial District: Grant, Haskell, Morton, Seward, Stanton, and Stevens counties
- 27th Judicial District: Reno County
- 30th Judicial District: Barber, Harper, Kingman, Pratt, and Sumner counties

TOGA wallet accounts

To pay filing fees to courts operating on the Kansas eCourt case management system, you must set up a TOGA wallet account under your user profile in the [Kansas Courts eFiling system](#).

You must set up your account before you can begin to pay filing fees through the eFiling system when you file in courts operating on the Kansas eCourt case management system.

Courts in Track 6 will require a TOGA wallet account for eFiling payments beginning September 12.

Track 6 go-live impact on courts in Tracks 1, 2, 3, and 5

There will be minimal impact to courts in Tracks 1, 2, 3, and 5 when data from Track 6 courts is added to the Kansas eCourt case management system.

From **5 p.m. Friday, September 9**, to **8 a.m. Monday, September 12**, the Kansas eCourt case management system will be offline for courts in Tracks 1, 2, 3, and 5. The courts will not accept electronic filings or electronic payments.

The [Kansas District Court Public Access Portal](#) will not be able to retrieve case data from these courts during this time.

Courts affected are:

- 2nd Judicial District: Jackson, Jefferson, Pottawatomie, and Wabaunsee counties
- 4th Judicial District: Anderson, Coffey, Franklin, and Osage counties
- 5th Judicial District: Chase and Lyon counties
- 6th Judicial District: Bourbon, Linn, and Miami counties
- 8th Judicial District: Dickinson, Geary, Marion, and Morris counties

- 11th Judicial District: Cherokee, Crawford, and Labette counties
- 12th Judicial District: Cloud, Jewell, Lincoln, Mitchell, Republic, and Washington counties
- 13th Judicial District: Butler, Elk, and Greenwood counties
- 14th Judicial District: Chautauqua and Montgomery counties
- 15th Judicial District: Cheyenne, Logan, Rawlins, Sheridan, Sherman, Thomas, and Wallace counties
- 17th Judicial District: Decatur, Graham, Norton, Osborne, Phillips, and Smith counties
- 19th Judicial District: Cowley County
- 20th Judicial District: Barton, Ellsworth, Rice, Russell, and Stafford counties
- 21st Judicial District: Clay and Riley counties
- 22nd Judicial District: Brown, Doniphan, Marshall, and Nemaha counties
- 23rd Judicial District: Ellis, Gove, Rooks, and Trego counties
- 28th Judicial District: Ottawa and Saline counties
- 31st Judicial District: Allen, Neosho, Wilson, and Woodson counties

Track 6 go-live schedule

To prepare Track 6 courts to convert from FullCourt to the Kansas eCourt case management system, courts in Track 6 must stop taking filings and payments made electronically.

[Supreme Court Administrative Order 2022-CC-067](#) establishes the conversion schedule for Track 6, which begins at **6 p.m. Wednesday, September 7**, and ends at **8 a.m. Monday, September 12**.

The conversion schedule is:

Wednesday, September 7

At 6 p.m., Track 6 courts stop taking electronic filings and electronic payments.

Thursday, September 8, and Friday, September 9

Track 6 courts will be open and operating during regular business hours and accepting paper filings. Payments must be made in cash or by paper check.

Monday, September 12

At 8 a.m., Track 6 courts are fully operating on the eCourt case management system and electronic filing and electronic payments resume.

Supreme Court Rules 20–25

Unless otherwise indicated, these rules apply to courts as they are brought onto the Kansas eCourt case management system. They require the filer to correctly designate the case and document type. They also require the filer to indicate if the document complies with Rule 24 protecting personally identifiable information or if it is filed under seal.

These rules are necessary to protect individuals' personally identifiable information as district court records are made accessible through the public access portal as part of the Kansas eCourt case management system.

Supreme Court Rules 20–25 are known as the [Kansas eCourt rules](#) and they can be found on the [Search Rules page](#).

Future tracks

Track 9, which is the 18th Judicial District (Sedgwick County), had an anticipated go-live date of October 31. It will be moved to 2023 to allow Office of Judicial Administration support teams to focus on courts in Tracks 5 and 6 as they adjust to operating on the new case management system.

Go-live dates for Tracks 7, 8, and 10 are yet to be scheduled. These tracks include courts in metro areas in northeast Kansas and appellate courts. Courts that had been in Track 4 were distributed to other tracks and the track number retired.
